# Counselling Sessions Privacy Policy

This Privacy Policy outlines how we collect, use, store, and protect your personal information when you interact with our services. ### 1. Information We Collect:

- Your discussions with your therapist and any notes they write, are confidential and will not be disclosed to any other person without your consent. Therapists are required by their profession to have regular sessions with a supervisor, where they may discuss aspects of your therapy. Your identity will never be revealed during these sessions.
- Legal obligations: In certain circumstances, we may need to process your personal information to comply with legal or regulatory requirements. For example: if your therapist is required to disclose information by a court of law, or in order to protect you or another person from significant harm.

### 3. Information Security:

We are committed to ensuring the security and confidentiality of your personal information. We implement appropriate physical, electronic, and managerial procedures to safeguard and secure the information we collect. However, please note that no data transmission over the internet or electronic storage system can be guaranteed as completely secure.

## 4. Sharing Your Information:

We respect the privacy of your personal information and do not sell, trade, or rent it to third parties. However, we may share your information in the following circumstances:

- With your consent: We may disclose your information to third parties if you provide your explicit consent for a specific purpose.
- Service providers: We may engage third-party service providers who assist us in delivering our services, such as appointment scheduling or payment processing. These providers have access to personal information solely for performing their functions and are obligated to maintain its confidentiality.
